## A Life Remembered: Margaret R. Stancil, Generous Benefactor

Margaret Rawls Stancil was a woman who valued her community and spent her life serving it. Her community included New Bern, but was not restricted to it. Born and raised in Pamlico County, traveling the world, she was much more about diminishing divisions than creating them.

Margaret's marriage to Lieutenant Joseph Calvin Stancil, United States Army, was cut short when he died on July 16, 1944 of wounds received in the Battle of Normandy. For the rest of her life, she remained loyal to his memory and to his family.

Margaret was an educator, both professionally and in her leadership in the community. She never sought attention for herself, seeking instead to bring attention to causes that she supported both with her personal efforts and with her philanthropy. Anyone who knew Margaret knew that she was always gracious, but direct. Things did not need to be complicated. She simply chose to use her resources, both personal and financial, to improve the lives of others.

Generous throughout her life, in her later years Margaret chose to create endowments with the Craven County Community Foundation, a chapter of the North Carolina Community Foundation. One of those endowments is designated for the New Bern Historical Society, specifically for improvements and maintenance of the Attmore-Oliver House and other buildings on the downtown campus. Distributions from that endowment have been enor-

mously helpful and we are grateful. Margaret's beneficiaries also include the Pamlico County Historical Society and many other organizations including hospitals and schools.

Always a leader, Margaret hoped that her gifts would be used wisely and well, and that they would inspire others to give, most especially to contribute to endowments. Having been a generous leader all of her life, through these endowments, Margaret continues to lead. The New Bern Historical Society, like the many other organizations

that she continues to benefit, will always honor her memory by being good stewards of her gifts.

### JOURNAL ARTICLE: Luke Martin, Sr. (by Nelson McDaniel)

This year marks the 150th anniversary of the Battle of New Bern, a battle that changed the fate of this town and our state and nation. Many of us have family stories that grew out of that war. For many of us whose families have lived in this area for generations, our ancestral connections are to the Confederate Army, Yet there are also many North Carolina families with connections to the Union Army. Perhaps the closest connection in our state and, undoubtedly, one of the closest in the nation is that of Luke P. Martin, Jr.

Luke Martin's father, Luke P. Martin, Sr. was one of the first formerly enslaved black men to enlist in the African Brigade, eventually the 35th United States Colored Troops. In January of 1863, President Abraham Lincoln signed the Emancipation Proclamation. Shortly

after, in the spring of that year, Luke P. Martin, Sr. escaped from his slaveholder's plantation near Plymouth, N.C. and braved swamps and rivers to reach freedom in New Bern. Here, on May 22, 1863, he enlisted in the North Carolina Colored Infantry led by Colonel James C. Beecher, brother of *Uncle Tom's Cabin* author, Harriet Beecher Stowe. In service at the Battle of Olustee, Florida in February of 1864, Luke Martin was wounded.

After the war, Mr. Martin settled in New Bern and married. He helped establish St. John Missionary Baptist Church and served as its pastor. He built a home (the same one in which Luke P. Martin, Jr. lives today) and had two children by his first wife. After her death he married Miss Abbie Pender of Brices Creek in 1905 and five children were born to that un-

ion, the youngest being Luke P. Martin, Jr.

Luke P. Martin, Sr. died when his son, Luke, was only three years old, and young Luke was raised by his remarkable mother. For his whole life he has been a contributor to the community, serving St. John Missionary Baptist Church and many other causes. Mr. Martin has been a master mason whose work can be seen around the area and the country including at the restored and reconstructed Tryon Palace. Stories abound of his uncompromising search for perfection in this field.

Mr. Martin has often been heard to say, " I'm blessed and I have had a good life. Life owes me nothing and my days have been good." For a man who, at 95, still goes to work every day, it is not surprising that his favorite song is "I Won't Complain."

At the spring annual meeting, the New Bern Historical Society was pleased to honor Mr. Martin for his remarkable and moving connection to the Civil War, but, also, for his own contributions to our community. He was also the guest of honor at the Civil War Veterans Day Ceremony during which wreaths were laid at the three cemeteries in New Bern where veterans of that war are laid to rest, Cedar Grove, Greenwood and National.

Mr. Martin is one of New Bern and North Carolina's most important treasures and we wish him many more happy years. When asked how long he plans to continue working he responded.

" I'm contracted to 100, and after that we'll just see." What a remarkable man.


